## EXTENSIONS

Some of the main extensions and conditions include;

- Associated holiday travel is covered
- Travel is limited to a maximum of 180 days
- Cover whilst participating in tenpin bowling training and events

## EXCLUSIONS

Please refer to the policy wording for a full list of exclusions via the Travel Policy. The main exclusions affecting TBA members are as follows;

- Sporting equipment whilst in use is not covered.
- Pre-existing medical conditions.

The insurer will not be liable for any expenses that are:

1. Incurred directly or indirectly from a journey:
  - a) undertaken against the advice of a medical practitioner;
  - b) undertaken when the insured person is unfit to travel;
  - c) where the purpose of the journey is for the insured person to seek medical attention; or
  - d) taken after a medical practitioner informs an insured person that they are terminally ill;
2. Incurred directly or indirectly from routine medical, optical or dental treatment or consultation
